Special Remarks on the Products of Biodegradation:

If released to soil, copper sulfate may leach to groundwater, be partly oxidized, or bind to humic materials, clay, or hydrous of iron and manganese. In water, it will bind to carbonates as well as humic materials, clay and hydrous oxides of iron and manganese. Copper is accumulated by plants and animals, but it does not appear to biomagnify from plants to animals. This

lack of biomagnification appears common with heavy metals. In air, copper aerosols (in general) have a residence time of 2 to 10 days in an unpolluted atmosphere and 0.1 to >4 in a polluted, urban areas. (Copper sulfate pentahydrate)
